

## **IMLCA TRASH POLICY**

ALL GARBAGE MUST BE IN A SEALED BAG INSIDE OF A SEALED CONTAINER. NO MORE THAN **5 CONTAINERS** (32 GALLONS EACH) TOTAL PER WEEK. **NO LOOSE BAGS MAY BE PLACED OUT FOR COLLECTION.**

TRASH **SHOULD NOT** BE PUT OUT BEFORE SUNDAY EVENING.

CONSTRUCTION MATERIAL MUST BE IN A **CLOSED CONTAINER** (ONE PER WEEK).

ABSOLUTELY NO VEHICLE PARTS, TIRES, BATTERIES, ETC.

AIR CONDITIONERS & REFRIGERATORS MUST HAVE CFC'S AND HCFC'S **PROFESSIONALLY** REMOVED.

LAWN MOWERS MUST BE FREE OF GAS AND OIL.

ANIMALS MAY GET INTO YOUR FOOD WASTE REGARDLESS OF HOW IT IS PLACED AT CURBSIDE. PROPERTY VALUES AND SALES SUFFER WHEN TRASH IS LITTERED AROUND THE COMMUNITY. THE LONGER YOUR TRASH IS AT CURBSIDE THE MORE LIKELY AN ANIMAL WILL GET INTO IT. FOOD WASTE SHOULD BE PLACED OUT AS LATE AS POSSIBLE. AMMONIA SPRINKLED INSIDE THE PLASTIC BAG WILL KEEP ANIMALS AWAY. ASK NEIGHBORS FOR OTHER TIPS.

### **RECYCLING IS MANDATORY IN IML**

RECYCLING CONTAINERS SHOULD BE CLEARLY MARKED AND ONLY CONTAIN PLASTICS WITH THE RECYCLING LOGO, GLASS, AND ALUMINUM THAT HAS BEEN **RINSED CLEAN**. THESE ITEMS MAY BE PLACED OUT IN A CLEAR PLASTIC BAG (NO KITCHEN BAGS, SUPERMARKET BAGS OR BLACK PLASTIC BAGS).

CORRUGATED CARDBOARD MUST BE CUT INTO PIECES 2 FEET BY 3 FEET AND TIED IN A BUNDLE NO THICKER THAN 1 FOOT (**NO PIZZA BOXES**). PIZZA BOXES WILL BE TAKEN BUT MUST BE BUNDLED IN WITH NEWSPAPER AND TIED.

### **BULK ITEMS**

NO MORE THAN ONE ITEM ANY WEEK (IT IS A GOOD IDEA TO CALL J.P. MASCARO AND LET THEM KNOW).

NO MORE THAN 2 ITEMS IN ANY CALENDER MONTH.

CALL J.P. MASCARO IF YOU ARE NOT SURE WHAT IS COSIDERED BULK.

**ANY TRASH LEFT ON A COLLECTION DAY MUST BE REMOVED FROM CURBSIDE AND PLACED OUT FOR THE NEXT COLLECTION DAY. ANY PROBLEMS OR QUESTIONS SHOULD BE DIRECTED TO J.P.MASCARO 800 243-7575. BE SURE TO TELL THEM YOU ARE WITH INDIAN MOUNTAIN LAKE CIVIC ASSOCIATION.**
